## SECTION 4: FIRST-AID MEASURES

### 4.1. Description of first aid measures

*General information:*

If breathing is irregular, drowsiness, loss of consciousness or cramps: Call 911 and give immediate treatment (first aid).

If unconscious, roll the injured person into recovery position. Call an ambulance.
